

Notification

In partial modification of the Department's earlier notification No. AGRI-18012/2/2025/3 dtd 17th June/2025 and in order to achieve the target of oil palm area expansion under the National Mission on Edible Oils–Oil Palm (NMEO–OP), it is hereby ordered that farmers possessing any of the following categories of land holding, already under their possession, shall be eligible for getting assistance under the scheme, **provided that the farmers' names are registered in the PM-KISAN database and these farmers have been receiving PM-KISAN benefits for at least 3 years.**


ELIGIBLE CATEGORIES

- i. Those farmers having land allotment certificates issued by the competent Revenue Officers of the Government of Assam to the extent admissible under the Assam Land Policy 2019. In Autonomous Council area it should be as per allotment certificates issued by competent authorities in Autonomous Council.
- ii. Those farmers cultivating on NC lands for a considerable period and are otherwise eligible for allotment of land patta as per Assam Land Policy 2019 to the extent as admissible under the Assam Land Policy 2019.
- iii. Those persons previously paying Encroachment Fine (Bedakhali Jarimana) for encroaching upon Government Land and having the documentary evidence of paying such fine and who are also otherwise eligible for settlement of Government Land as per Assam Land Policy, 2019 to the extent as admissible under the Assam Land Policy 2019. Encroachment fine document is not acceptable on VGR, PGR or any reserve forest area.
- iv. Persons paying Touzi Bahira revenue and are otherwise eligible for settlement of Government Land as per Assam Land Policy, 2019 to the extent as admissible under the said Land Policy.
- v. Those having permissions to hold and cultivate land under Debottar land or Satra land where permissions have been issued either by concerned authority like Debottar authority, or Satradhikars or other head of institution and a certificate issued to that effect by concerned authority is available for verification. In case of tea garden land, it shall be utilized by the tea garden authority for the specific purposes and within the limits prescribed as per Gazette Notification No. LGL. 193/2021 /15 dated 14/10/2022.
- vi. Those who are doing organized special cultivation for herbal or medicinal cultivation in case of patta land and have in this regard a certificate given by Revenue Circle Officer on the basis of report from the concerned Land Record Assistant (LRA) to the extent as admissible under the Assam Land Policy 2019. In case of Government land, clause 4 of Assam Land Policy, 2019 shall suitably be incorporated.
- vii. Those who have rights through inheritance, even though formal paper work has not been carried out in the land records. In such cases, Revenue Circle Officers can have the same verified through LRA/ Gaon Pradhans using birth certificates etc. for establishing rights over the land (applicable for only Patta land).
- viii. Small tea growers, commercial plantation and horticulture farmers who have land documents and certificates issued to them by Revenue Circle Officer on the basis of report from LRA to the extent as admissible under the Assam Land Policy 2019.
- ix. Farmers cultivating in the permanent river islands (Char chapori land) for a considerable period to be certified by competent authority.
- x. Any other person who does not have land documents, but prima-facie is eligible for getting land under the Assam Land Policy 2019 to the extent as admissible under the Assam Land Policy 2019.
