Sir.

With reference to the above, I would like to inform you that because of complex procedure for completion certificate along with preparation of MB etc. receipt of completion certificates of vermin compost units are delayed due to which the fund release procedure could not be completed within 31st March, 2017.

The matter was discussed in last SLEC Held on 3rd April, 2017; where in it was decided to follow a simple procedure for completion certificate which will includes declaration from the beneficiary (Part I) and completion certificate by the ADO and Junior Engineer (Agri.). The DAO will monitor at least 5% of the total completed units and will submit the report to this Directorate, based on which the fund will be released by means of DBT to the beneficiaries accounts. The format is enclosed herewith for necessary action in connection with completion certificate of the pending vermin compost unit under MOVCD. You are requested to arrange for completion of vermin compost units construction by the farmers for entire 500 nos. of each MOVCD clusters.
